Notice regarding the policy of holding the Continuing Meeting of the 48th Ordinary <u>General Meeting of Shareholders</u>

We Daito Trust Construction Co., Ltd, would like to announce that it has decided at the Board of Directors meeting held today to hold the Continuing Meeting of the 48th Ordinary General Meeting of Shareholders.

1. The Company planned to report its financial results of 48th fiscal term, etc., to shareholders at the 48th Ordinary General Meeting of Shareholders scheduled to be held on June 28, 2022. However, as stated in the "Notice of investigation regarding improper accounting treatment of our consolidated subsidiary" which was disclosed on May 24, 2022, a research team, including outside experts, is currently investigating the matter, and it is expected to take longer than initially expected. As a result, it will be impossible to report financial results of 48th fiscal term, etc., at the 48th Ordinary General Meeting of Shareholders.

Therefore, we are planning to get approval to hold a separate meeting of this general meeting (the Continuing Meeting), where we will report the financial results of 48th fiscal term, etc., and to leave the decision of the date and place of the Continuing Meeting to the board of directors at the 48th Ordinary General Meeting of Shareholders. If the above proposals are approved, we will send an additional convocation notice of the Continuing Meeting.

Since the Continuing Meeting is part of the 48th Ordinary General Meeting of Shareholders, the shareholders who can attend the Continuing Meeting are the same as the shareholders who can exercise their voting rights at the 48th Ordinary General Meeting of Shareholders.
