We Daito Trust Construction Co., Ltd. Note that the Company, as announced on January 20, 2023, plan to shift to a "Company with an Audit & Supervisory Committee," subject to the approval of the 49th Ordinary General Meeting of Shareholders to be held in June 2023.

#### 1. Background of the Change

Under the medium-term five-year plan (FY2019-FY2023), the Company have been working to strengthen and expand our core business, construction and real estate business, and peripheral businesses with the aim of becoming a total lifestyle support company based on the rental housing business. Although our business activities were severely impacted by the COVID-19 outbreak in December 2019, we were able to grow to more than 1.2 million rental housing units under management by seeking new sales methods and engaging in new businesses in the face of headwinds.

While the impact of the COVID-19 infection continues to this day, the government is reviewing its legal status of the disease, and efforts for adaptation to the infection to regain ordinary times are moving forward, and the Company is also making progress in normalizing its business activities and recovering its performance accordingly.

Against this backdrop, the environment surrounding companies is changing by the minute. The challenges that companies need to address are increasing, such as the declining and aging population, rising prices and natural disasters, and the drastic changes in the global situation. We believe that it is imperative for us to address these challenges and enhance our corporate value through sustainable growth and resolution of social issues in the future.

In June of this year, we will celebrate our 50th year in business and plan to shift to a "Company with an Audit & Supervisory Committee" upon a decision at the Ordinary General Meeting of Shareholders to be held in June.

Taking this opportunity, under the new management structure, we will accelerate decision-making and strengthen supervisory functions, and promote medium- to long-term corporate value enhancement through practical corporate governance.

The management structure shown below was resolved at a meeting of the Board of Directors held today based on the personnel requirements for the successor to the President, etc. as defined by the Nomination and Remuneration Committee and the results of deliberations from the perspective of whether the person is suitable to lead the Company's growth over the medium- to long-term.
