Obtained "SBT Net-Zero" Certification for Greenhouse Gas Emission Reduction Targets

Aiming for "Net Zero" CO2 emissions throughout the value chain by 2050

Tokyo, February 1, 2024 – the Daito Group (Headquarters: Minato-ku, Tokyo) has obtained the "SBT (Science Based Targets)^{×1} Net-Zero" certification from the SBT Initiative for our greenhouse gas emission reduction targets, to which we committed in April 2023. Our company group aims to achieve net-zero greenhouse gas emissions across the entire value chain by 2050 through initiatives such as transitioning company vehicles to electric vehicles (EV) and the promotion of environmentally-friendly housing.



Current Status and Outlook for Greenhouse Gas Emission Reduction

More than 80% of our group's greenhouse gas emissions are attributed to the energy consumption associated with the occupancy of rental housing built by our group, assuming residents live there for 35 years. Reducing the greenhouse gas emissions generated by residents' daily lives is directly linked to achieving our s group's emission reduction targets. Therefore, we aim to promote the adoption of environmentally-friendly housing, such as Net-Zero Energy House (ZEH) rentals and Life Cycle Carbon Minus (LCCM) house, in order to reduce emissions. Additionally, through collaboration with suppliers, transitioning company vehicles to EVs, and promoting the use of renewable energy in our business operations, we are committed to decarbonization efforts both internally and externally, with a steadfast focus on achieving our net-zero target by 2050.



- By fiscal year 2030, aims to achieve a 55% reduction in energy-related CO2 emissions. (Scope 1 and 2^{2/2}) from business activities compared to fiscal year 2017.
- By fiscal year 2030, aims to achieve a 55% reduction in CO2 emissions (Scope 3^{**3}) during the use of rental housing compared to fiscal year 2017.

- %5 LCCM (Life Cycle Carbon Minus): Homes that reduce greenhouse gas emissions during construction, occupancy, and disposal through renewable energy generation, achieving a net-zero or negative carbon emissions balance over the lifetime of the building.
